Why Travel Time Doesn't Count for Hours:

When considering sanctioned projects for a county, one of the requirements, on the proposal, should be the location of the project. If the location is on the far side of the county, you must make sure that you have volunteers that will want to maintain that project. The reason that we do not count drive time to a Sanction Project is because it is not fair to the other members in the group that live close to the projects. If a member lived further away from the project and they get to count drive time hours, they would meet their required hours way before a member who lived nearby. The Sanctioned Project work hours are usually based on the amount of work time it would take to maintain that project. If drive time was allowed to be counted, the actual Sanction Project work would suffer. The only advantage with travel time to and from Sanctioned Projects, it can be reported as volunteer mileage on taxes. If there comes a time that a Sanctioned Project starts to suffer due to location/drive time, this maybe the time that the project is reviewed/evaluated and becomes a community project and no longer Sanctioned.
